A little about Masonry and our history

No one can be certain when the Masonic Fraternity was formed. There is a widely accepted theory, among Masonic researchers, that it arose out of the stonemason's guilds during the Middle Ages. The oldest document to make reference to Mason's is the Regius Poem printed around 1390. The Grand Lodge of England was formed in 1717 and the Grand Lodge of Scotland in 1736, our first Grand Master being William St. Clair of Roslin. During the 18th Century Freemasonry was one of the organisations responsible for spreading the ideals of what we know as the Enlightenment. But what is Freemasonry? It is a society, not a secret society, for men who are concerned with moral, social and spiritual values. Its members are taught a number of value precepts and it does this through a "series of ritual dramas." (Grand Lodge of England, 2002) Freemasonry is NOT a religion, nor is it a threat to religion. It expects each member to have a belief in a Supreme Being and is therefore open to men of any religion, creed, race or denomination. Freemasonry does not believe in sectarianism but it is non political and as an organisation stands aloof from all political theories. Members are expected to be promoters of three major concepts: Brotherly Love, Relief to those in need and Truth in requiring high standards of morality. This makes Freemasonry a way of life and not just a hobby. It is not a secret society, all of its teaching can be found in the Holy Bible or whichever Book a man finds best to express his Religion, all Books known to Freemasons as the Volume of the Sacred Law. However like other organisations, Freemasonry believes that its internal affairs are private.

The Province of Linlithgowshire was instituted on the 5th November 1827 by Grand Lodge, with 4 Lodges: Linlithgow 17, Bathgate 13, Ratho 85 and Midcalder 272. Essentially the Provincial Grand Lodge covered the old County or area of Linlithgowshire. As we all know counties and district boundaries have changed over time, albeit somewhat radically in the 1930's. However, the Provincial Grand Lodge of Linlithgowshire boundaries have remained so and have grown to supervise 19 Lodges from Ratho to Harthill and from Boness to Fauldhouse: 13, 17, 85, 272, 374, 409, 548, 590, 636, 827, 927, 1145, 1186, 1232, 1305, 1587, 1601, 1614, 1658.

However in addition we have a number of Commissioned Office-Bearers who are commission by either Grand Lodge or the Provincial Grand Master and they serve for a period of five years. This is enough for now, we can tell you more later but in the meantime welcome and I look forward to meeting you at the welcome seminars and at a Triennial meeting of the Province.
